### 4.9. Termination of the agreement

Both parties can terminate the agreement by providing 4 weeks' notice in writing. Notice from the Certified Trainer will be delivered to Sue Langley, Langley Group CEO.

Upon termination, you will stop using the material, certification and associated LG content or approach. LG will cease acknowledgement of your LG Certified Trainer status on marketing and all associated company material.

If the agreement is terminated prior to the end of the 12 month period, no reimbursement of annual fees will be given.


